INCREASE YOUR DONATION AT NO EXTRA COST

If you are a taxpayer, then completing this form will also enable Lark in the Park to claim back some of the tax you have already paid! This is true whether you are making a single or regular donation.

For every £1 you give, LiTP can claim an extra 28p from the taxman. So, if your gift is £10 you pay £10, but Lark in the Park will receive £12.80!
